## Interview

**Tell us about your current role, career so far and how did you first start working in tax?**

I currently work as a Tax Partner in UHY Azerbaijan, where I focus on tax compliance, tax technology implementation, digital transformation and tax consulting. Over the course of my career, I have developed expertise in key areas such as tax technology, international tax and data analytics. My journey in tax began at early stages of my career, when I was responsible for Tax Compliance of one of the leading IT companies in Azerbaijan. Since then, I have continuously pursued opportunities to expand my knowledge and adapt to the evolving landscape of tax, especially the growing integration of technology in tax administration and compliance.

**What area of tax do you work in and how did the tax technology qualification help you in your day-to-day job?**

I work primarily in tax compliance. DITT has significantly enhanced my day-to-day work by deepening my understanding of digital tools and processes such as Making Tax Digital, robotic process automation, and data analytics. This knowledge enables me to optimise tax processes, improve accuracy and compliance, and effectively collaborate with both technical and tax teams to drive digital transformation within the tax function.

**What motivated you to undertake this qualification?**

Break down the material into manageable sections and set realistic study goals for each session. Engage actively with the content by taking notes, highlighting key points, and reflecting on how the concepts apply to real-world tax scenarios. Regularly test your understanding through practice questions and revisit challenging topics as needed.

**Which module did you enjoy the most and what were the most relevant to your current role?**

The module I enjoyed the most was Making Tax Digital and Digital Transformation because it directly aligns with the ongoing changes in tax administration and the integration of technology into traditional tax processes. This module provided valuable insights into real-time reporting, automation, and digital compliance, which are highly relevant to my current role in tax compliance.

**How do you think this programme will benefit the profession?**

This programme is set to benefit the tax profession significantly by equipping professionals with the knowledge and skills needed to navigate the rapidly evolving digital landscape.
