

# Statement of personal assets - liabilities and business interests

### When to use this form

Use this form to give us a statement of your worldwide assets, liabilities and business interests.

If you prefer you can prepare your own statement instead of using this form, but it must be signed and dated, and use the same wording as the declaration on page 9 of this form.

If you have assets or liabilities of a kind not listed on this form, you include these under 'other assets' and 'other liabilities'.

Providing false or incomplete information on this form or your own prepared statement may result in prosecution.

#### How to use this form

Give a brief description of the assets, for example:

- address of property
- · name, branch and number of bank account
- type of vehicle

If you cannot fit everything into this form, please continue your statement on a separate piece of paper. You must then sign, date and attach each additional page to this form.

In the 'Assets' section you should show the balance of each bank or similar account. Show other assets at cost price, including where appropriate, purchase expenses and date of purchase. For property, also show the cost of any improvements or alterations and the dates these were made.

If you're unable to obtain a record of cost, you can use an estimate and put an 'E' next to the figure.

Clothing and household furnishings can be shown as a collective valuation (please explain how you've valued them). Where items are insured, use the insurance value.

There are separate columns for your own assets and for assets owned by any minor children you have who are under 18, or under 16 in Scotland. Do include assets held jointly or in common with others.

If you hold any beneficial interest in any asset jointly or in common with others, make this clear in the description. Only use the amounts attributable to the person completing the form.

The statement should include all assets, wherever in the world they are held, in which you, and any minor children you have under 18, or under 16 in Scotland, have a beneficial interest, even if they are held by a trustee, nominee or in another name.

The statement should include all liabilities and you should show the amounts outstanding in the 'Liabilities' section.

### How we use your information
