Cookie	Name	Purpose
Chatbot	Userld	Used by the webchat.botframework.com if you use the chatbot facility This cookie is set by Beamer to store the date of this user's first interaction with insights.
	_Beamer_First_Visit	This cookie is set by Beamer to store an internal ID for a user.
	_Beamer_User_ID	This cookie is used to detect the first pageview session of a user. This is a True/False flag set by the cookie.
Hotjar	"_hjAbsoluteSessionInProgress"	This is set to identify a new user's first session. It stores a true/false value, indicating whether this was the first time Hotjar saw this user. It is used by Recording filters to identify new user sessions.

	"_hjid"	Hotjar cookie that is set when the customer first lands on a page with the Hotjar script. It is used to persist the Hotjar User ID, unique to that site on the browser. This ensures that behaviour in subsequent visits to the same site will be attributed to the same user ID.
	"_hjTLDTTest"	When the Hotjar script executes we try to determine the most generic cookie path we should use, instead of the page hostname. This is done so that cookies can be shared across subdomains (where applicable). To determine this, we try to store the _hjTLDTTest cookie for different URL substring alternatives until it fails. After this check, the cookie is removed.
Kentico	CookieConsent	This cookie is used to remember a user's choice about cookies on tax.org.uk. Where users have previously indicated a preference, that user's preference will be stored in this cookie.
Universal Analytics (Google)	_ga	These cookies are used to collect information about how visitors use our website. We use the information to compile reports and to help us improve the website. The cookies collect information in a way that does not directly identify anyone, including the number of visitors to the website and blog, where visitors have come to the website from and the pages they visited.
