

## Your Portal

As a student you will have become familiar with the Portal, where you managed exam bookings etc. The Portal remains the central place for you to manage your membership too.

Each year we will send you a notice for renewal in November by email. This will be a call to action for you to log in to the Portal and pay your subscription for the year ahead and submit your Annual Return for the previous year. Annual Subscriptions and Annual Returns are due by 31 January each year. You can submit and pay online through the Portal. Invoices marked paid are sent automatically to members by email and these can be used (where agreed) to expense the cost of your membership back to your employer.

### Anti-Money Laundering

If you are a business in the tax and accountancy sector you or your firm must be supervised. In essence this means sole practitioners and principals in partnerships/limited liability partnerships and companies operating in that sector. For you or your firm to be supervised by the CIOT at least one principal in your business must be a member of the CIOT (Principal for these purposes means sole practitioner, equity partner, member of an LLP or company director at Companies House). ## Branch Network

A Joint Network with the Association of Taxation Technicians bringing the profession together as a community via peer-to-peer learning and networking.

The Branch Network community is made up of a friendly volunteer group of CIOT and ATT members from your area, who will deliver an annual programme of events tailored to local members and students.

- Branch events include professional skills training, and other social events
- Free or low cost seminars, webinars, meetings, and discussion groups
- The chance to develop your technical expertise and obtain Continuing Professional Development (CPD) hours
- Valuable networking opportunities with likeminded professionals and a chance to practice your networking skills.
- Personal development including building and maintaining your professional status

In 2022, the Branch Network delivered 87 events, 22 of these were in-person events in the UK and Channel Islands attracting over 1,000 delegates.





## Conferences & events

Our members receive access to our national events programme. Our events calendar plays an important role in making education in taxation accessible and inclusive with many events being offered free of charge or at a reduced, affordable rate.

### Global Events

The Chartered Institute of Taxation has licensed the Irish Tax Institute, The Tax Institute of Australia, the South African Institute of Taxation and the Taxation Institute of Hong Kong to use the designations 'Chartered Tax Adviser' (CTA). Since 2021 we have collectively produced a series of Global CTA seminars aimed at tax practitioners in these jurisdictions. Members are entitled to attend.

The CIOT are also proud to host virtual events on behalf of TaxAid and Tax Help for Older People, the two tax charities which we support. They provide vital services to those in need, please support them if you are able to.
