

Basic teaching and learning adjustments

Valid from 1 September 2026 up to and including 31 August 2027

The adjustments listed below are not automatically available to all students. Teaching and learning adjustments are always granted on the basis of an individual assessment by a study adviser. This assessment takes your personal situation into account, as well as a relevant diagnosis or statement.

Adjustment	Description
Formal decision required	
Assistive listening system / audio induction loop system	Use of assistive listening system by lecturer/audio induction loop system – equipment to be supplied by the student.
Sign language interpreter	Use of a sign language interpreter if necessary (including Canvas guest account) – the student is responsible for covering the costs of the sign language interpreter from their personal budget/UWV benefit.
Live subtitling	Ava application licence (use of live subtitles during lectures).
Speech-to-text interpreter	Online access to speech-to-text interpreter during lectures
Field trip buddy companion	Field trip: buddy companion - the student is responsible for covering the costs from their personal budget/UWV benefit.
Field trip: own room	Field trip: own room - the student is responsible for covering the costs from their personal budget/ UWV benefit.
Building accessibility	The student has certain limitations regarding access to specific areas, as specified in SIS.
Adapted furniture	The student is entitled to adapted furniture as specified in SIS. Available options differ per teaching room; the allocation is determined by the relevant Education Service Centre.
Emergency services	Student with a medical condition provides instructions on how to act in case of an emergency.
Converting a book/text to PDF	Converting a physical book or physical text to PDF. After the adjustment has been granted, the student must report to the University Library, location Vendelstraat.

For the adjustments listed below, it is not necessary to apply for formal approval. However, it is possible to do so, so that lecturers and support staff are informed in advance that the student will make use of this support tool during teaching activities.

Adjustment	Description
In consultation, no formal decision required	
Sunglasses*	Student wears sunglasses during lectures and/or tutorials – sunglasses to be supplied by the student).
Use of medication*	Medication on table and medication use – medication to be supplied by the student*
Use of mobile phone*	Student uses mobile phone during lectures and/or tutorials due to medical reasons
Walk around*	The option to occasionally walk around during lectures and/or tutorials
Assistance dog*	Student is accompanied by assistance dog during lectures and/or tutorials
Non-electronic ear defenders	Non-electronic ear defenders (as sold in DIY stores) – to be supplied by the student*

Things to note:

- Every year in June, the basic list is reviewed, re-established, and published for the subsequent academic year. This list is valid from 1 september 2026 up to and including 31 August 2027.
- Provisions marked with an * do not conflict with existing regulations and/or follow from legislation, and therefore no formal decision is required for them. The student may use these provisions in consultation with the study adviser and/or lecturer. The provision is only recorded in SIS after consultation with the student.
