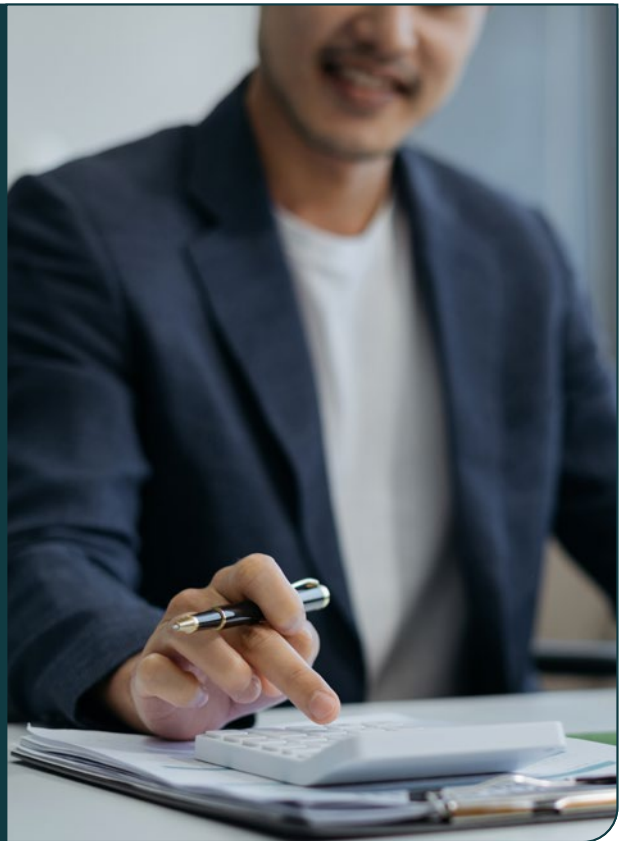

OUR EXPERIENCE

ISTEPLARNING - LONDON

A corporate nursery operator, Isteplearning, approached CFRE to assist with managing cashflow whilst they were undertaking a series of acquisitions to expand their portfolio of 23 nurseries. Requiring funds within 10 working days, we arranged a 12-month short term facility for £1.1 million against five freehold nurseries and met their deadline.



CARE HOME REFINANCE

We were able to source a £1.2m facility over a 12-month period, to assist in the extension of a care home, which refinanced the client's existing facility and provided 100% of the development costs on a tranche basis. The facility was completed within 3 weeks of enquiry and the first tranche was delivered a week before Christmas.



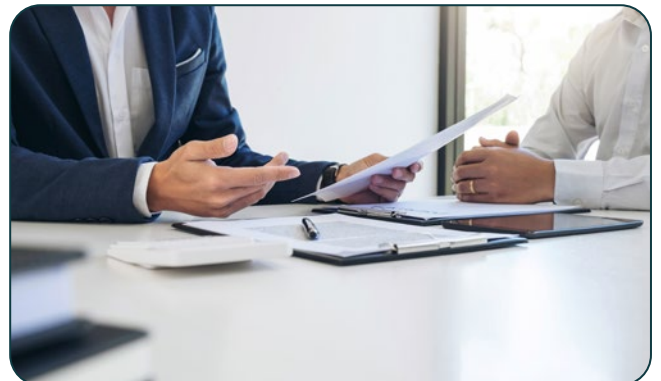
IBIS - BRADFORD

SHORT-TERM BRIDGING FACILITY

We completed a short-term bridging facility for a client who was looking to release capital from two of his pharmacies to assist with cashflow & further acquisitions. Funds were required within 2 weeks which meant we did not have time for conventional options through market funders. We delivered this within the timescales, using a private funder we work closely with.



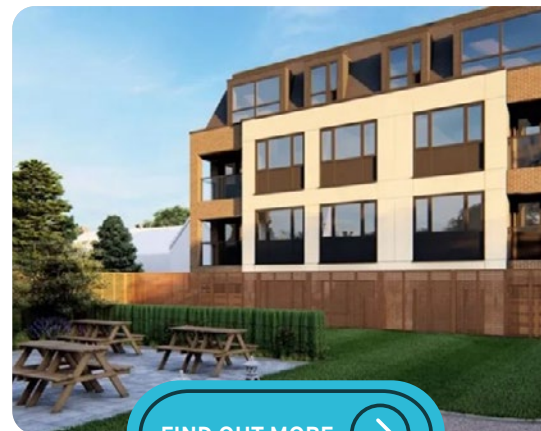
