## **NOTES FOR GUIDANCE:**

In order to stand for election as a TSSA Staff Representative, prospective candidates **must**:

- be a member of TSSA;
- be employed by Great Western Railways;
- be in a management grade within Trains Service Delivery department;
- be currently employed in a post covered by the constituency for which a candidate seeks election;
- have a minimum of six months service with Great Western Railways;
- support the principles of the TSD Collective Bargaining Procedure.

Prospective candidates **must** also be supported by six nominators, each one of whom **must**:

- be a member of TSSA;
- be employed by Great Western Railways;
- be in a management grade within Trains Service Delivery department;
- be currently employed in a post covered by the constituency for which a candidate seeks election;
- have a minimum of six months service with Great Western Railways;
- support the principles of the TSD Collective Bargaining Procedure.

If there are not 6 eligible nominators for a particular constituency, prospective candidates should contact Alan Valentine for guidance.

Prospective candidates should complete the nomination form in full. It is particularly important that TSSA has up to date contact details for reps. Failure to complete all parts of the nomination form may result in the nomination being declared invalid.

All information on the nomination form will be treated by TSSA as strictly confidential.
