

## GPR ESG+ Index rebalancing

Global Property Research announces the final constituents of the GPR Europe ESG+ Index, GPR Europe ex-UK ESG+ Index and GPR Eurozone ESG+ Index, which will become effective as of 23 November 2020 (start of trading). The selection of stocks of each relevant index series is based on the TOP 50 constituents with the highest monthly trading volume, measured as the twelve month trading volume in US dollars over the previous twelve months. The constituents included in the relevant ESG+ index series are assigned a base weighting derived from (i) their free float market capitalization on the date of periodic adjustment and (ii) their newly announced GRESB score (if available based on the GRESB Real Estate Assessment otherwise on the GRESB Real Estate Public Disclosure).
