

20th, 2025, foreigners may fill in the relevant entry information online before coming to China through NIA's official website, Government Service Platform, "NIA 12367" APP and WeChat (Alipay) mini program or by scanning the QR code with mobile phones. Foreigners who cannot fill in the information online in advance may complete the process upon arriving at the immigration inspection site in the ports of China by scanning the QR code with mobile phones or using the smart devices at the port to fill in the entry information online or filling in the paper Arrival Card.

The following 7 types of foreigners may be exempted from filling in the Arrival Card:

- a. holding a People's Republic of China Foreign Permanent Resident ID Card;
- b. holding a Mainland Travel Permit for Hong Kong and Macao Residents (Non-Chinese Citizens);
- c. holding a group visa or eligible for group visa-free entry;
- d. transiting directly within 24 hours without leaving the restricted area of the
- e. entering and exiting with the same cruise ship;
- f. entering through fast lanes;
- g. foreign employees of exit-entry transport vehicles.

There are mainly 4 online filling channels as follows

a) National Immigration Administration APP 📮 🕽



Passengers can download the National Immigration Administration App and click on "Foreigner Services" on the homepage, access the "Arrival Card Filling" function to complete personal information. Passengers using the cellphone of Android system can scan the QR code below to download and install the APP. IOS and HarmonyOS users can download and install the APP from their respec-

When passengers access the Foreigner Arrival Card Filling System via mobile devices, they will see two functional entrances: Entry Declaration and Entry Declaration



Those entering the country with a valid visa are required to fill in the visa number. For 24/240-hour Temporary Entry for Transit, it is necessary to fill in "whether the document is lost or stolen". For emergency temporary entry permits, it is necessary to upload explanatory




ENTERING THE COUNTRY WITH A VALID VISA

Click the "Add" button in the upper right corner to enter the "My Accompanying Person (s) " page, and select the companion to be added. Passengers can click the "New" button in the upper right corner to enter the information of new companions.









8 After clicking "Submit", fill in the declaration statement and sign, then click "Confirm" to complete the filling and enter "The Entry Declaration Receipt" page. Passengers can download "The Entry Declaration Receipt" in PDF format to the local device or send it to a specified email address.

THE ENTRY DECLARATION RECEIPT






Instructions for PC Web Access

The operation on the PC web page is similar to that on the mobile web page. It does not support registered users to log in and use, and cannot manage companions, reuse or cancel the filling records.


1 Enter the arrival card filling page.



Click to select "Entry Declaration" to enter the Business Notice page, read and agree to the application notice. Then enter the "Uploading ID Document" Page Upload web page, upload the picture of the ID document page. When you hover the mouse over the picture of the ID document page, a delete button will appear, and you can delete and re-upload the picture of the ID document page.




(3) Click "Next"to enter the "Basic Information Filling" Page.




At this time, the applicant can check the basic information of the document recognized by the system, make corrections if there are any errors, and then fill in information such as the means of entry transportation.





