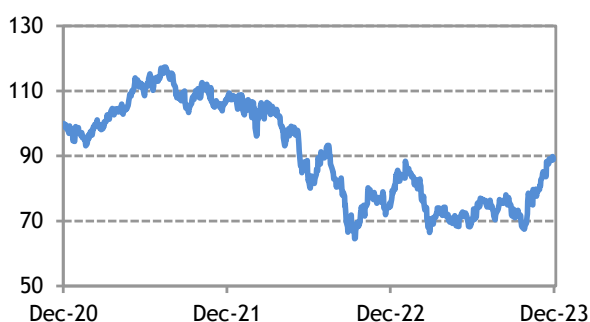

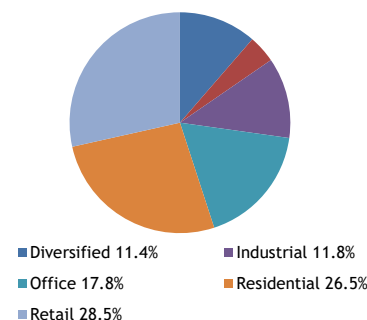
Rules for company inclusion

- Size >50 USD million Free Float Market Cap
- Investibility >15% free float
- Real estate activity >75% operational turnover
- Rental income >25% operational turnover
- Sector allocation >60% operational turnover from one specific sector, else Diversified
