### PaDare - Tax Conversations with ZITA

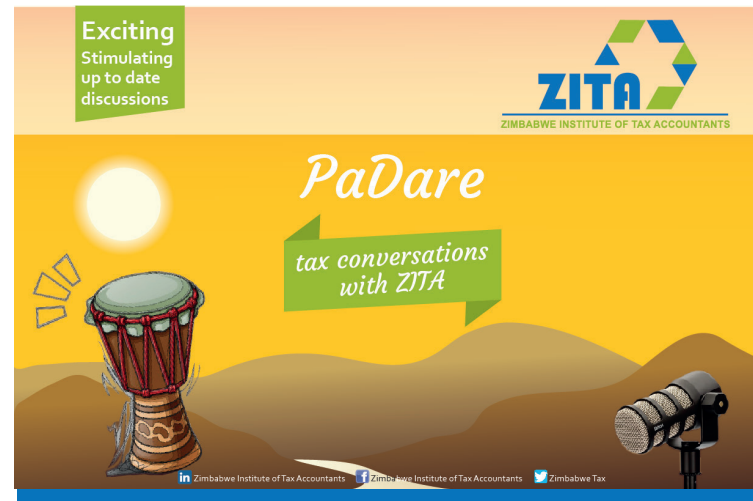
#### Concept:
