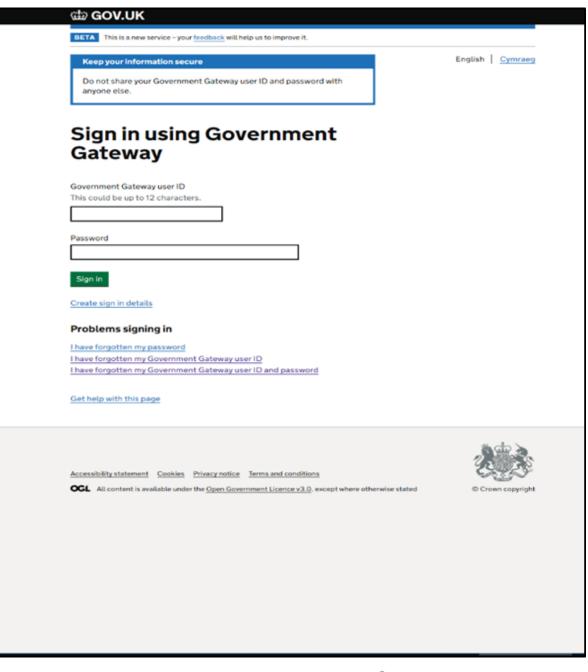

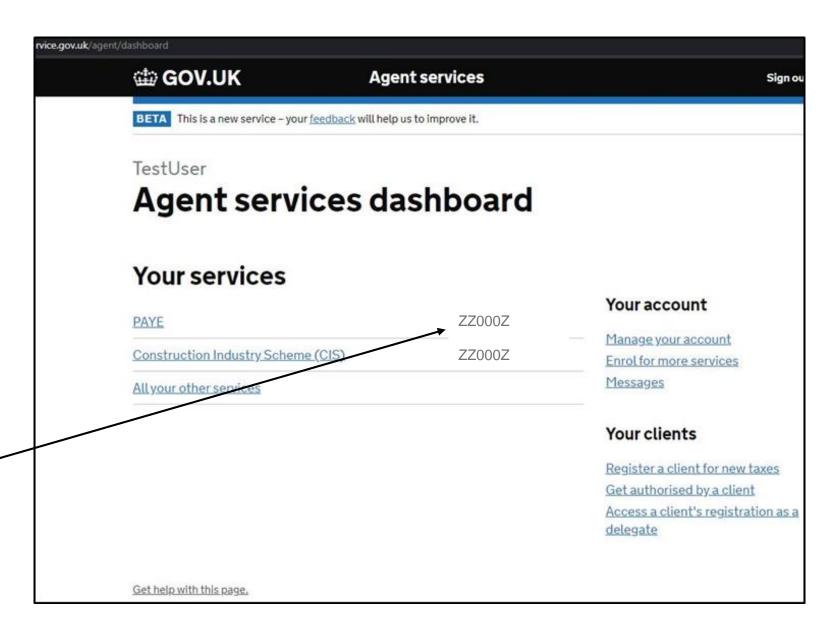

New screens

The next few slides show the new pages that you can view for liabilities and payments. The right-hand navigation menu provides links to all the new pages:

- Annual statements pages show a summary for each tax year with a snapshot for each tax month. If you select the Tax period link eg 6 Apr to 5 May (month 1) this will take you to the Monthly statement which shows a breakdown for that tax month.
- **Payment history** page shows all the payments received in a tax year, and the tax month(s) to which the payment (or parts thereof) was allocated.
- Upcoming payments page shows liabilities where the Due Date is today, or a date in the future.
- Overdue payments page shows liabilities where the Due Date is in the past.
- **Employment Allowance** status page shows whether the employer is receiving employment Allowance for the current tax year, or not.

You can move from one page to another using the right-hand navigation menu which is the same on every screen, or by using links on a page.

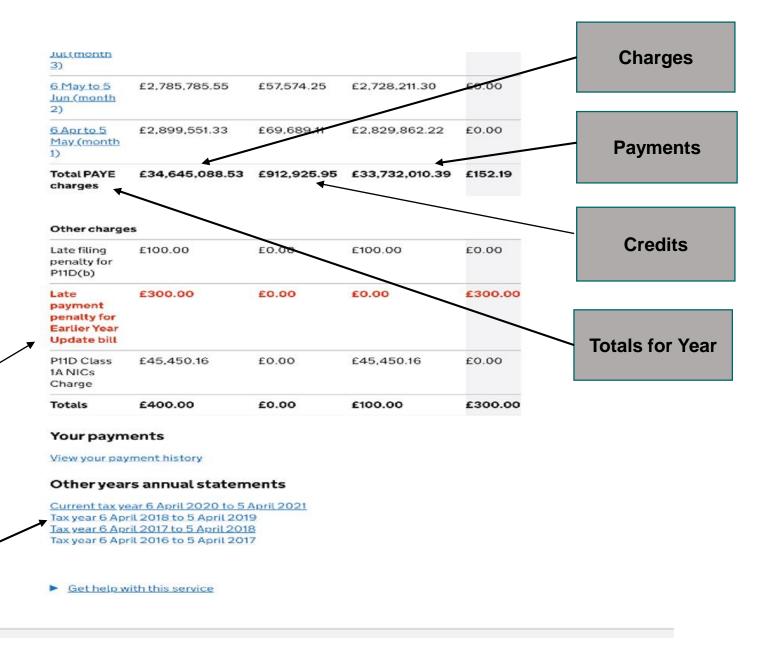

This section shows the Full payment submissions (FPS) liabilities including:

- Student and Postgraduate Loan Deductions

- In-year Class 1A NICs

If they are a negative amount they will show in the Credits section.

These sections will show any other liabilities including:

- Construction Industry
- Apprenticeship Levy (Note this wasn't shown on the old screens

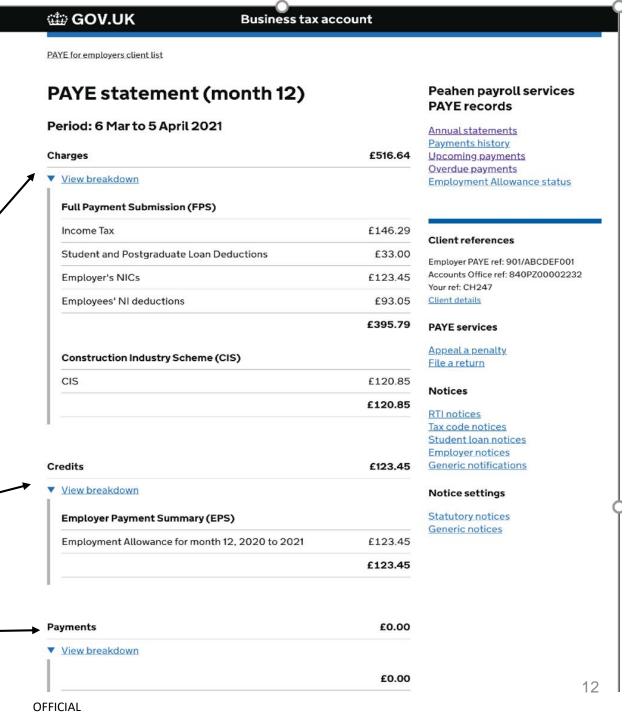
