Tell us about your current role, career so far and how did you first start working in tax?

I began my career in the India tax office of a US multinational corporation, where I gained foundational experience in US tax reporting and compliance. This role provided me with a solid understanding of tax fundamentals and exposure to the intricacies of mulinational tax structures.

I then transitioned to Accenture's tax transformation team in India. Here, I did my first tax technology implementation project for a client in South Africa. I subsequently joined Deloitte USI and later PwC UK, advising multinational clients across North America and EMEA regions respectively, on tax optimisation strategies and navigating finance transformation projects.

I now work at Intellicore Consulting Group, where I've leveraged my extensive experience in tax to assist businesses in the United Arab Emirates navigate the evolving tax landscape and implement tax technology solutions tailored to their needs.

What area of tax do you work in and how did the tax technology qualification help you in your day-to-day job?

Primarily, my focus lies in corporate income taxation, where the introduction of new regulations in the Gulf region and of Pillar Two legislation has made the integration of technology increasingly important for efficiency and compliance. My role is to understand the client's financial and tax landscape, their processes, pain points, strategies and goals with a view to provide a tailored solution to address their requirements.
