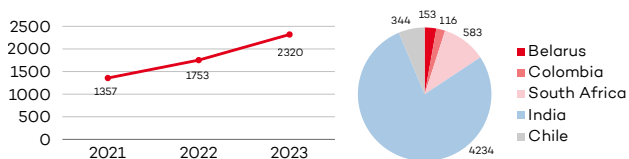
Our impact on global HSCT accessibility

The outcome of haematopoietic stem cell transplantation (HSCT) is influenced by many factors, including the search, selection and timely procurement of cellular products from donors.

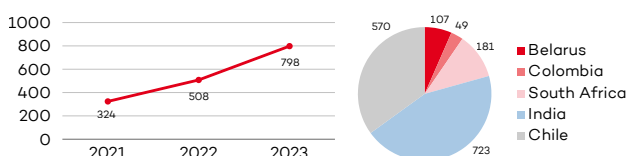
To simplify this process, the DKMS Registry **developed a multinational search and request support program**. This is **specifically designed for transplant centers (TCs) in countries without national registries or limited resources, but where unrelated donor HSCT is emerging**. Cooperative TCs receive access to the worldwide donor pool via the DKMS Registry's Hap-E Search tool, training, and hands-on support as part of the support initiative. From initially addressing patient needs in India, our initiative extended to Chile, South Africa, Colombia, Belarus and other countries.

Our data covering the period from Jan 2021 to Dec 2023 indicate **a positive trend in HSCT activities in the countries receiving our support**. Overall a 43% increase in unrelated donor searches, a 59% increase in pre-workup requests, and a 40% increase in workup requests was observed. A total of 561 cellular products were delivered in that time period, of which 35% were procured domestically and 65% internationally.

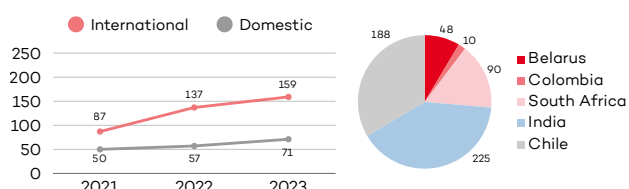
Unrelated donor searches for all cooperative TCs

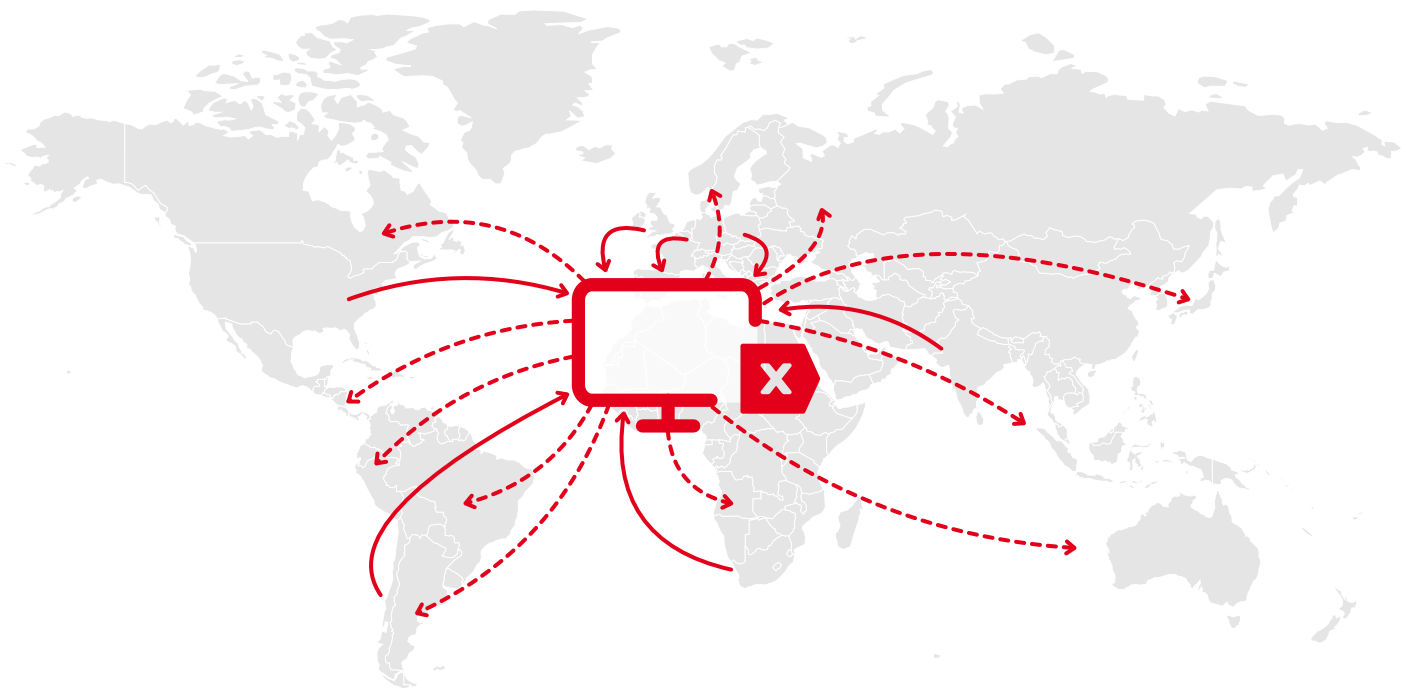
