High street boost for Middlesbrough with new Newcastle Building Society branch and community space

Newcastle Building Society has delivered a boost to Middlesbrough town centre and the local community with the opening of a new branch on Linthorpe Road, bucking the national trend of branch closures and improving access to financial services on Teesside.

Part of a multi-million-pound investment in branches across the North East, the Society has relocated its Middlesbrough branch to a bigger and more prominent location, which includes a dedicated space for local charities and community groups.

Customers, colleagues and members of the community helped celebrate the official ribbon cutting at an event this week. Newcastle Building Society CEO, Andrew Haigh, was joined by Sue Kearney, CEO of The Hope Foundation alongside representatives from charities including Age UK Teesside and Daisy Chain as well as the Middlesbrough Rotary Club to formally open the doors to the new branch.

More than half of Newcastle Building Society branches now include a community room, which are free-to-use spaces for charities and groups to meet up. Open to customers and non-customers, the spaces are one way the Society makes a difference in communities and helps create positive change for local people.

Despite the national trend in bank branch closures, Newcastle Building Society has continued to invest in its branch network by improving and increasing its number of branches across the region. Over recent years, the Society has opened branches in several new locations by sharing space in community hubs, and helping to restore access to financial services in places where banks have left town.

It's a strategy that is working for the Society, and growing its high street presence while other financial services providers disappear from communities has seen its branch savings balances grow at a rate of more than double the whole-of-the-market average.

Andrew Haigh, chief executive officer at Newcastle Building Society said: "We're delighted to formally open the doors to our new Middlesbrough branch. Investing in the branch means

better facilities for customers and colleagues and secures the future of financial services in

the town centre. It's essential that people in our communities can have a real conversation

about their money, preserving that vital access to trusted financial advice and information.

High streets are better with branches and whoever you are, there are times when speaking to

someone face-to-face is best.

"That's why we're investing significantly into our branch network, committing to Middlesbrough

and giving customers a proper choice - whether they want the convenience of our online

services, or a friendly face on our high streets.

"Feedback from customers is fantastic, which is reflected in the growth we've experienced in

the number of members, branch savings balances and high customer satisfaction levels

across the business."

Since 2015, more than 6,200 bank branches have closed across the UK, including several in

the North East, forcing customers to travel miles to get to their nearest branch and making it

harder for some people to manage their money.

Other recent branch investments by Newcastle Building Society include the refurbishment of

its Hartlepool branch, a new branch in Pickering, North Yorkshire, and a new community

partnership branch in North Shields. Future investment for the Society includes work on a new

flagship location in Newcastle city centre, and a collaboration with North Tyneside Council to

open a new branch in Tynemouth Library, following planned redevelopment.
