The Bank or Building Society logo or name must be shown.

- The bank statement must show the applicants full name or initials and surname including their address. If we have requested the bank statement for proof of residency then it must match the address we have requested it for.
- The date must be shown on the bank statement, if this is for residency, we can only accept it for the date and address it was issued not the date of transactions. For salary fed bank statements, it must be from within the last two months and match the payslip provided.
- The sort code and account number must be displayed on the bank statement.

Outgoings must match those declared on the application form (E.g. Direct Debits for loans and credit cards).



If the statement provided is a current account, there must be debits to show day to day living costs.



If the statement has been requested to match the payslip we only need the one page where this is displayed. We do not require months of bank statements unless this has been specifically requested.



For salary fed bank statements, online statements can be accepted. We cannot accept online statements for proof of residency.



If there are any large transactions we may query these.



We do not accept statements where the information has been amended, is unclear or blocked out.

Statements must show a running balance.
