IF THIS HAPPENS	DO THIS
Vehicle accident	Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks. <b>Call the emergency services: Dial 111</b>
Spill or leak	Prevent further migration into the environment. Prevent spilled material from flowing onto adjacent land or into waterways. Use absorbent material to solidify liquid. Sweep up or vacuum. Wear protective equipment including eye protection to avoid exposure. Large spills due to traffic accidents, etc., should be reported immediately to CHEMCALL and Elanco Animal Health for assistance.
Fire	<b>Call the Fire Service: Dial 111.</b> May emit toxic fumes when exposed to heat.

### FIRST AID

If swallowed	If product is swallowed, give plenty of water to drink. Contact a Poisons Information Centre / doctor immediately.
If in eyes	If splashed in eyes, flush eyes with plenty of water. Obtain medical attention.
If on skin	If skin or hair contact occurs remove contaminated clothing and thoroughly wash affected areas with water.
If inhaled	Remove patient to fresh air. Get medical attention if breathing difficulty develops.

### STORAGE AND SEGREGATION

**Storage:** Store securely at room temperature (below 30°C) in a dry place in a tightly closed container. Do not store in direct sunlight. Do not freeze. Keep out of reach of children.
