

A shorter period of protection may occur if CLIKZIN is applied incorrectly, if there is excessive fleece soiling or if wool infections such as mycotic dermatifis (fleece rot) are present. CLIKZIN can be applied to damp sheep, however do not apply during heavy rainfall or when such conditions are expected before the product can dry on the fleece.
