are applied and that this factory production control fulfills all the prescribed requirements.

This certificate can only be used in conjunction with the declaration of performance of the product written by the manufacturer or his authorised representative established in the European economic area and with the technical specification in reference.

This certificate is issued on 30 October 2018, it replaces the certificate previously delivered on 22 February 2017 and, except for withdrawal or suspension, remains valid as long as the conditions laid down in the corresponding technical specification in reference or the manufacturing conditions in the factory or the factory production control itself are not modified significantly.
