Equality, diversity and inclusion at Sovereign

At Sovereign we are firmly committed to the principles of equality, diversity and inclusion that will help us to be a better employer and service provider.

Moral case

The principles of equality and diversity are about social justice, fairness, human rights, equal access to opportunities and are simply the right thing to do.

We recognise there are risks associated with non-compliance. These risks include the effect on our reputation, financial implications and the impact on those involved.



Equality legislation and regulations

Equality legislation

As an employer and housing provider, we seek to ensure that people have equal access to services and employment opportunities. As a social housing provider, we have certain responsibilities under the Equality Act 2010 to promote equality of opportunity. The Equality Act 2010 makes discrimination unlawful in relation to nine 'protected characteristics.

Equality Duty

The Public Sector Equality Duty requires Housing Associations delivering public services to give 'due regard' to the need:

- To eliminate discrimination, harassment and victimisation
- To advance equality of opportunity
- To foster good relations (tackling prejudice and promoting understanding)
 Sovereign is not a public body but is required to comply with the duty in the provision, allocation and management of social housing

Regulatory requirement

This policy meets the requirement of the regulatory framework which requires registered housing providers to respond to the needs of diverse residents.

Registered providers are required: to treat all residents and tenants with fairness and respect including protected characteristics and those with additional support needs.

Protected Characteristics

- Age
- Disability
- Gender
- Religion/belief
- Race

- Gender re-assignment
- Marriage (civil/same sex)
- Sexual orientation
- Pregnancy/maternity



Governance

Equality Governance

- The Sovereign Board and Chief Executive have overall responsibility for the implementation of this policy and compliance with the equality legislation. They have corporate responsibility to provide leadership for ensuring that this policy is reflected in all aspects of Sovereign's work.
- Sovereign has established a Equalities Forum which promotes equality, diversity
 and inclusion across the business and oversees the implementation of the
 equality, diversity and inclusion strategy. It monitors targets and action plans and
 provides leadership to embed equality, diversity and inclusion across all Boards
 and business activities.
- The board meets on a quarterly basis and will produce and communicate an annual report on its performance and achievements.
- Subsidiary Boards and the lead executive for each of Sovereign's Subsidiary companies are responsible for the operational delivery of the policy in relation to service delivery including monitoring of compliance against objectives and targets.
- The equality, diversity and inclusion strategy will set out detailed actions and collective responsibilities for all managers and employees at all levels of the organisation.
- The Executive Director People and Change has responsibility for delivering the strategy and is the equality, diversity and inclusion champion for the business.



Our Approach

Harassment, anti-social behaviour and domestic violence

Harassment, anti-social behaviour and domestic violence Sovereign is committed to dealing promptly and effectively with all aspects of hate related crime, harassment (racial and on other grounds), antisocial behaviour and domestic violence as it impacts on customers and communities as well as employees.

We have specific HR policies for employees on how to raise issues of harassment, bullying and whistle blowing. Employees may raise the issue directly with their line manager, a member of the HR team, any other manager or a member of an employee form.

Residents

Specific anti-social behaviour, domestic violence and harassment policies have been developed to ensure that we have an adequate, transparent and fast method of dealing with issues.

Our employees will be fully trained on a on-going basis to make sure that they are sufficiently knowledgeable to deal with such situations. Our approach is victim-centred and absolute priority is given to investigating any such report.

The need for positive action

We recognise that in society not everyone is treated equally and there are individuals and groups that are also socially excluded. To overcome barriers to fairness and to give equal opportunity, Sovereign will consider positive action measures, as appropriate.

Examples of our approach are:

- Setting of targets to encourage the recruitment of women in trade roles, an area of work that traditionally attracts more men.
- Improving BME representation among our Boards or Resident Involvement Groups relative to the balance in the community.
- And as a 'Two Ticks' disability employer we offer interviews to all disabled people who meet the basic job criteria.



Our Approach

Recruitment and employment

We are a progressive employer and committed to creating positive and inclusive workplaces with a well trained workforce. To help us achieve a representative workforce we will monitor our recruitment and promotion activities against the protected characteristics.

Learning and development

All employees, managers and boards will complete EDI e-learning and be given appropriate training on equal opportunities awareness and diversity best practice appropriate to their role. The Executive Director People and Change has overall responsibility for equal opportunities training.

Procurement and supply chain

Sovereign is committed to equality, diversity and inclusion in respect of achieving best value in all our procurement activities. We will make sure that our values are reflected by all external suppliers working on behalf of Sovereign and that they uphold the principles of this policy in all their dealings with our customers.



Communication and monitoring

Communicating our policy

We will make sure that this policy is made available and publicised on a widespread basis:

- The policy will be made available on our website.
- All employees, board members, applicants for jobs and contractors and consultants working for Sovereign will be advised of the policy.
- Customers will be advised of the policy through their Resident Handbook.
- The policy will be included in the employee handbook and discussed with all new starters during their induction.
- Contractors, bidders and suppliers will be advised of the policy through the tendering and contract review processes and will be expected to uphold the standards of this policy in everything they do.

Monitoring

We monitor and review our policy, strategy, employment practices, procedures and services to ensure fairness for all. We will make any changes to our policies and strategies as necessary, if, there are any significant changes to legislation, policy or practice.

All divisions will conduct an Annual Diversity Audit and Equality Impact Assessment of performance and compliance with this policy and report this to the Diversity Board, and Sovereign Board.

Data protection and confidentiality

The use of personal information will be treated with appropriate levels of confidentiality and will be fair and lawful. Sovereign will ensure that personal information is accurate; not kept for longer than is necessary; secure; and adequate, relevant and not excessive. All information will be processed in accordance with the data protection rights of the individual.
