## Think About Level 3 Custody and Detention Officer Project Report

As part of your custody and detention officer apprenticeship, you are required to complete a project report. The project report will be a written account of 1,500 words (+/-10%) and must be completed within 20 working days of going through the gateway process. You can work with your line manager to discuss the title and content of the project and confirm that it is suitable for assessment.

The project must draw on your experience gained throughout the duration of your apprenticeship and contain real-life activities completed in your role and also any research you have undertaken prior to gateway. Given the sensitivity of the information that may be contained within the reports you use, any names of individuals should not be included within your project. You should simply refer to an individual as 'prisoner A,' prisoner B,' etc.

The project will take the form of a report to the governor of your establishment and will detail how you have actively contributed to the wider rehabilitative culture change. Completion of a governor's report is an expected part of the custody and detention officer's role, therefore in your project ensure you include the following:

- the high importance to the sector of the rehabilitative agenda
- the responsibility that you personally play in contributing to the agenda
- you can clearly and accurately present information regarding a situation or incident in a report that may be required as part of a forensic or evidential process
- reflection of the skills, knowledge and behaviours you have learnt throughout your apprenticeship



Before beginning the project, work with your line manager and training provider to plan and ensure that your report covers all the assessment criteria in the five project sections in the Highfield EPA kit. You will need to cover all pass criteria to achieve a pass and cover all the distinction criteria in three of the five sections to achieve a distinction.

Highfield **recommends** that an appropriate way to structure the report is as follows:

Your report must be accompanied by the Written Submission Sheet which is available to download from the Highfield Assessment website.
