# **Working as an Early Years Educator**

The broad purpose of the occupation is to provide high quality early education and care to children. Through an evidence-based approach, they provide opportunities and learning experiences for all children, including those with special educational needs and disabilities (SEND).

In their daily work, an employee in this occupation interacts with children, parents, carers, colleagues, and wider multi-agency professionals such as health visitors, early help services, social workers, and speech and language therapists. This occupation is found in a range of maintained and private, voluntary, and independent settings such as full day care, children's centres and pre-schools.

# The programme's structure

The EPA period should only start, and the EPA be arranged, once the employer is satisfied that the apprentice is consistently working at or above the level set out in the occupational standard, all of the pre-requisite gateway requirements for EPA have been met and that they can be evidenced to an EPAO.

All pre-requisites for EPA assessment methods must also be complete and available for the assessor as necessary. The EPA must be completed within an EPA period lasting typically 3 months, beginning when the apprentice has passed the EPA gateway.

### The end-point assessment methods are:

### **Observation with questioning:**

- A 50-minute observation followed by 30 minutes of questioning
- Observing the apprentice completing their normal duties in the workplace
- A minimum of 5 questions

### Professional discussion underpinned by a portfolio of evidence:

- A 90-minute session professional discussion
- Portfolio of evidence submitted at gateway which is not directly assessed
- A minimum of 10 questions



### **Go** further

Completion of this education and childcare standard will allow those wishing to pursue, and/or advance a career in early years education into areas such as full day care, children's centres, preschools, reception classes, playgroups and nursery schools. With additional experience, an early years educator can become the manager of an early years setting.
