# **BOARD OF DIRECTORS - Brief Role Descriptions**

#### The following two Director roles are available for election at the 2023 AGM

#### **Operations Director**

To support the Chair and Board in the achievement of Strategic objectives and act as a confidential sounding board whilst promoting good governance and to provide an efficient administration service to the Area, ensuring the Area functions smoothly and effectively. Be the main communication link between internal and external stakeholders embedding effective membership consultation. All hockey related committee chairs report to the Operations Director to ensure synergies and operational alignment are achieved.

#### **Governance Director**

To be responsible for promoting good corporate governance and educating members, embedding and documenting good practice within the Area. Supporting the promotion of a proactive approach to player welfare and safety. Ensuring the data management systems are used appropriately and that information is held safely and kept updated, to help contribute to the efficient running of the Area. Establish credibility with stakeholders, including local authorities and educational establishments and help to maintain the integrity of the England Hockey brand to attract potential sponsors.

#### Other Director roles (not available for election 2023).

#### Chair

To provide vision, leadership and business planning to lead and develop all aspects of the Area, from playing and development to running the administration and fundraising. Ensuring that support for succession planning is in place, for the benefit of all. Current postholder – Tim Lorimer.

#### Vice Chair

To support the Chair in providing the vision, leadership and business planning to help develop all aspects of the Area, from playing and development to running the administration and fundraising. Ensuring that support for succession planning is in place, for the benefit of all. Current postholder – Nicky Dyke

#### **Finance Director**

To manage the Area finances, contribute to strategic business planning and review and recommend financial policies and controls for the Area to enable appropriate management information is available to underpin Board decisions. Provide contributions as a Director to the Area Board of Directors. Current postholder – Claire Wright.



# Lead Committee Chairs – brief role descriptions

To provide vision, leadership and business planning to help develop all aspects of Masters hockey across the Area in line with the England Hockey framework. To oversee the Masters committee ensuring partnership working between the Areas to deliver a robust programme, for the benefit of all.

#### **Chair Officiating**

To provide vision, leadership and strategic planning in all aspects of the Area Officiating in line with the England Hockey guidelines. To oversee the Officiating committee to ensure delivery of umpire developer and development pathways to umpires at all levels, with a high level of customer satisfaction. Being an important link between Officiating and the rest of the game.

#### **Chair Discipline**

To provide leadership to ensure effective management and delivery of all aspects of 'Area' Discipline and undertake tasks assigned by the National Disciplinary Panel (NDP) of which you will also be a member. To support review of disciplinary processes across the sport. (NB This is an appointed role, not elected at the AGM).

# **Governance Director**

### Name: Joanne Kennedy-Reardon

#### A little about Joanne Kennedy-Reardon:

In February 2023 I was co-opted to the Board of Directors of Midlands Hockey Ltd as Governance Director, part of the remit being to promote good corporate governance, educating members, embedding, and documenting good practice and supporting the promotion of a proactive approach to player welfare and safety. I bring a fresh perspective to the Board as a Chartered Director, Chair of North Stafford Hockey Club and a non-hockey player, in shaping an inclusive culture and effecting a cultural change in the Midlands which complying with the policies of England Hockey. Currently I serve as an Independent Member of the Audit and Risk Assurance Committee at the Valuation Tribunal Service and Chair of the Board and Nominations Committee at Taekwondo Organisation Ltd (TOL). The latter organisation TOL, supports its member bodies and Taekwondo clubs in the delivery of their participation programmes to around 38,000 members, providing an engaging forum to work together on common objectives. Previously I was an Independent Member of the Audit and Risk Committee at Equity Housing and on the Board of Brighter Future Housing Association (where I was also Chair of the Audit and Risk Committee). All of these organisations have reporting responsibilities to government sponsoring departments and/or Regulators and responsibilities which specifically include risk management, fraud awareness, whistleblowing and safeguarding alongside the fiduciary responsibilities as denoted in statute. Working with the founder of ReGen Future Planet, a UK non for profit with a global philanthropic model that works with businesses acting as a positive changemaker since 2019; I am focussed on shaping the strategic direction and providing management oversight on the structure, objectives, culture, and corporate governance arrangements along with risk management. Over the last 18 months, I have been Project Advisor to the Board of British Taekwondo Council Ltd that was shortlisted in the Governance Project of the Year 2022 category of The Chartered Governance Institute. I hold Fellowships at the Institute of Directors (IoD), the Chartered Institute of Management Accountants (CIMA), the Institute of Internal Auditors (IIA) and the Chartered Management Institute (CMI). I am an International Certified Internal Auditor, a Chartered Global Management Accountant (AICPA) and hold a Diploma in Islamic Finance. Recently I have completed a certificate in 'Understanding Mental Health First Aid and Mental Health Advocacy in the Workplace' and am concluding study on 'Equality and Diversity'.

# Name: Andy Barnes

### A little about Andy Barnes:

The following statement is to support my continued appointment as ADA to Midlands Area Hockey and the National Discipline Panel.

From Nottinghamshire I have been associated with Midlands Hockey for 48 years as a player, player coach, team captain, Umpire, Umpire coach and Hockey administrator with Club, County, Region and Area in many roles. I am an England Hockey Technical Official and World Masters Official. I have achieved Level 3 qualification as an Umpire and Umpire Coach.

I have 21 consecutive years of dealing with Hockey Disciplinary issues. 2002 – 2014 I was the Nottinghamshire County Discipline Administrator. In 2014 when I was seconded to cover the then Regional Discipline Administrator (RDA). I became the RDA officially in 2015 and continuously in post until 2021 when I was appointed as the first Area Discipline Administrator (ADA). As RDA and now as ADA I serve on the National Discipline Panel and have been on that Panel now for 9 years as the longest serving member. I have received awards for exceptional service to Barbados Hockey, Midlands Hockey and Blackpool Festival and hope all this experience enables me to bring fairness, understanding but with firm control to the roles of an ADA.
