Area Officiating Committee

As I write we are heading to the last week of league games for the current season. Many promotion or relegation battles have already been resolved, but there are still more to decide in the coming week. As officials we need to ensure that we maintain our sharp focus on delivering the best hockey matches that players can play – so that the results best reflect their

efforts throughout the season.

The fact that we have managed to get this far through the season is mainly due to the huge



amounts of hard work put in by your committee – so many thanks to them all for going well above and beyond in order to get us this far through the season. Thanks also to everyone who has undertaken officiating duties this season – whether you've umpired only a single game, or have undertaken multiple appointments each weekend across officiating, coaching and development. My thanks to each and every one of you. Without you we simply would not have managed a full season of hockey in the new organisation.

Umpire Development across the Area

We still also need to keep making an effort to develop new umpires and, as mentioned in previous newsletters, we in South Central have a Level 1 Assessment manager (Ray Hipkin) who can provide advice and guidance on how to develop umpires and help to get them through the assessment process. Ray has a number of documents that he can send you (we will also get them on the South Central website - www.southcentral.hockey) and then we can all start to plan development activities and assessments around all of our other officiating activities.

As previously, If you want help with sourcing an assessor for a Level 1 assessment then please let Ray know, with as much notice as possible (ray@rayhipkin.co.uk). Ray will also be able to help if you wish to discuss how best to prepare for a Level 1 assessment.

We can also offer more tailored support to clubs – simply contact the Club Liaison Officer (Rowena Shepherd) and tell her what your requirements are and we will see what we can arrange. Given the appearance of summer league games in the not too distant future we may be able to bring coaches to support umpire development in the sunny summer evenings, as long as we have plenty of notice and also have coaches available! Please get in touch as soon as you can.

Development

If you want to join the development process please let Ginette know, by registering for her Development group. To register go to www.umpiredev.co.uk, select "Information for Individual Umpires" and scroll down to find the Development Group button. You should be a Gold member of England Hockey Officiating in order to benefit best from the development opportunities which are available.

The membership fees for EHO should now have been collected, or be in the process of being collected; noting, of course, that Bronze membership is free!



If you are umpiring club games, or school games, or any other kind of hockey matches, you do need to be a registered member of EHO.

We have recently developed a document, aimed mainly at Club Umpire Developers, with some advice and guidance on how to manage, and protect, young umpires so that they develop and maintain their umpiring careers and are not put off umpiring for life. The document will be appearing on the South Central website shortly and we will also try to send it out directly to Club Umpire Developers, where we have their contact details.

Rules Refresher

9.13 Players must not tackle unless in a position to play the ball without body contact. Reckless play, such as sliding tackles and other overly physical challenges by field players, which take an opponent to ground and which have the potential to cause injury should attract appropriate match and personal penalties.

9.14 Players must not intentionally enter the goal their opponents are defending or run behind either goal.
