

As you can imagine we have a lot of work to do to establish how the committee will function and how each of the sub-groups will deliver their specific function. We also have to work out how to operate the new England Hockey Game Management System (which will include what used to be called the Officiating Management System – OMS).

Club Liaison Lead

As you can see, we still have a vacancy for the Club Liaison Lead and we'd be very happy if anyone who is interested in this role got in touch. We envisage the role as leading a team of local club liaison people – we have over 70 clubs in South Central and one person can't manage all of them on their own. So, we'd see a team, with each person taking responsibility for a small group of clubs, and with a Lead to ensure that the messages going to clubs are generally consistent. 

Fixtures

Fixtures have now been published for all of the various divisions within the South Central Adult leagues – they can be found at:

Each division has been allocated a grade – where Grade 1 is the EH National League (Premier, North and South and the Four Conferences) as shown here:



The grades have some relevance as different umpire requirements apply to different grades. All will be documented in the league rules, to be published shortly.

Appointing for friendly fixtures, before the leagues start, will either be done through GMS, as and when it is available, or through the existing HUA websites (subject to agreement of the County HUA). Clubs with friendly matches organised, who would like appointed umpires, should contact South Central in the first instance

It doesn't matter whether you only want to umpire once or twice a season, in club games, or whether you want to progress your umpiring career – please complete the form so that we can get as full a picture as possible.

Expenses

We are very aware that the matter of expenses is an important one for all of our officials, and we continue discussions with EH on this issue. At time of writing no decisions have been taken and there are a variety of options on the table; including a standard set of fees across all 8 Areas or each Area being able to set their own remuneration policy. More details will be available as we have them.

England Hockey Officiating (EHO)

EHO is being set up, by England Hockey, to be the club to which all officials must belong. We are still waiting to find out the membership costs, and the benefits at each level of membership. There will be a free membership option and we await details of that.



It is likely to be in the league rules that all umpires, for any league match, must be members of EHO, and there may well be penalties applied if umpires are

used who are not EHO members. Such membership can be applied for retrospectively but this should be the exception rather than the rule.



Website

Many of us are used to being able to access all sorts of officiating related documentation on the existing County HUA websites. IN future those websites will be faded out and replaced with the South Central website, which will have specific pages allocated to officiating. The structure of the new website isn't yet fully developed, meaning that our existing County HUA sites may well continue for a while, but the intent is to provide all of the necessary South Central officiating information in one place. Watch this space for more details as and when we know them.


Work is going on within England Hockey to further develop OMS, and also to provide training materials, probably in the form of "How to" videos, so that using the new system doesn't come as too much of a shock as we move towards the new season. Officials will be able to enter their availability, and also to add notes to help the Appointing team (e.g. if you are also playing you can put those details in, so that the appointers will know where you will be, and what times you will be available).

League Fixtures

The league fixtures have been released and are on the EH website. There are a couple of errors in names of teams and they will be corrected once the Game Management System (GMS) goes live in August. For those teams in Ladies Solent Division 2 and 3 we have looked at equalling out the number of teams in each division and a team from Solent 3 has agreed to move up to Solent 2 so there will be a need to amend the fixtures for both divisions but again that will be done shortly.

The league rules are at the final stage of approval along with the fair play selection paper.

The Adult league committee has been formed and the individuals named will be your clubs first call of contact going forward. The names and contact details you need for the new season ahead are on the following pages.

The Junior section are planning to use all the dates available for matches in the centralised calendar for most age groups. Please be aware that all ages, genders from U14-U18 will play on the same dates so this will inevitably put pressure on pitches.

When the leagues are released there will included play offs at the end of the season. They will work like this:

U14 Boys / U14 Girls / U16 Boys **TIER 1** – Top 2 teams form each Pool will play in a playoff to find the top 3 teams for Tier 1 Supra League. U14s playoffs will be on 28^{th} November and U16 Boys playoff will be on 5^{th} December

U16 Boys Tier 1 – Once top 3 teams have moved up to the Supra league we will look to integrate the remaining 3 teams into Tier 2 if possible.

U14 Boys /U14 Girls / U16 Boys / U16 Girls **TIER 2** – Top 2 Teams from each Pool will play in the finals day on 24th April

U14 Boys Hants **Tier 3** – They only have 7 league dates so there will be playoffs between the 2 pools for all teams on dates 6 March & 27 March

U14 Girls Hants **Tier 3** – Finals day between top 2 teams from each pool on 24 April

U16 Girls BBO **Tier 3** - They only have 7 league dates so there will be playoffs between the 2 pools for all teams on dates 6 March & 27 March

Finance Update
