BOARD OF DIRECTORS

Finance Director

Governance Director

Name: Leighan Bleasdale

I have been the North West Adult Leagues and Competitions Chair for two years delivering the adult league competition programme and managing the transition towards the new league structures and regulations. Since 2016 I was a member of the North League Committee where I was a Division Coordinator for the women's league and the West Area Administrator where I managed the men's and women's league committee west of the Pennines and prepared for the 8 Area structure we have today. I have also held the position of Chairperson of the Lancashire Central Women's Hockey League and Vice President of the Lancashire Hockey Association.
