You will be asked to vote on the following proposals on the night:

#### 1) The Proposals for Membership Subscription Fees are as follows;

The Company proposes that the Member Subscription payments to the Company to be considered at the AGM be as follows:

For Voting Member Clubs, the proposal for Subscriptions shall be £10.00\* per adult league team

For Voting Junior or Occasional clubs, the proposal for Subscriptions shall be £10.00 per club

For the EHO the proposal for Subscriptions to be set at zero

For Sub-Areas and other Organisations, the proposal for Subscriptions to be set at zero

# 2) The Proposals for entry and other fees for Competitions and Leagues are as follows;

The Company proposes that the entry fees for the Midlands Adult leagues will be set at £20.00\*\* per team.

The Company proposes that the appointment fee for officials appointed to Midlands Adult league matches will be set at £20.00 per official.

The Company proposes that the entry fee for the Midlands Adult indoor hockey finals tournament will be set at £100.00 per team

The Company proposes that the entry fees for the Midlands Junior club league will be set at £20.00 per team.

It is proposed that all other fees for all other competitions and events be set by the Directors following informal consultation with the relevant lead committee(s).

# 3) The Proposal for use of surplus funds raised via Adult League fines is as follows:

The Company proposes that £3000 of funds raised via fines issued by the Adult League Management Committee (ALMC) during the 2022/23 season, be used to provide umpire development initiatives. The initiatives will be agreed between the ALMC and the Officiating Committee, for the benefit of all Midland clubs participating in the Leagues.

### 4) The Proposals for commitment to support the EH Talent Academy Hardship Fund are as follows:

England Hockey have asked the Areas to give financial support if required to Talent Academy players. The Directors feel this is not a board decision and seek approval from the membership:

Should Midlands Hockey Ltd support the EH Talent Academy Hardship fund?

If yes to the above should the funds (proposed £1500) come from

- A) Supplementary increase in membership fees of £2.50 per team
