This guidance is to be used for all International Sportsperson governing body endorsement requests made on or after **1 July 2025**.

Section 1: Overview of governing body endorsements for the International Sportsperson route of the points-based system

This page provides a brief explanation of what endorsement requirements apply in respect of the International Sportsperson route of the points-based system. The Immigration Rules for the International Sportsperson route can be found at <u>Appendix International Sportsperson</u>.

The International Sportsperson route is for elite sportspeople and coaches who:

- are internationally established and whose employment will make a significant contribution to the development of their sport at the highest level in the UK
- who will base themselves in the UK
- will be filling a post that cannot be filled by a suitable British citizen or person who has a right to enter or stay in the UK without restriction.

The application process explained: migrants applying to come to the UK under the International Sportsperson route need to be sponsored by an organisation that has an International Sportsperson sponsor licence.

If you wish to sponsor such migrants, you must have a sponsor licence. Before you apply to the Home Office for a licence you must be endorsed by the relevant **sports governing body** for your sport. This endorsement confirms to the Home Office that the application for a licence is from a genuine sports club (or equivalent) that has a legitimate requirement to bring migrants to the UK as sportspeople. Once licensed, you can assign certificates of sponsorship to a sportsperson or coach with a job offer that allows them to apply for entry clearance or permission to stay in the UK. Each individual must also have a personal endorsement from the relevant **approved sports governing body** for their sport before you assign the certificate of sponsorship.

An **approved sports governing body** is one specified in <u>Appendix Sports Governing Bodies</u> of the Immigration Rules. Each governing body must be recognised by one of the home country sports councils such as Sport England, and will have been approved by the Home Office before being included in <u>Appendix Sports Governing Bodies</u> of the Immigration Rules.

Sports governing bodies will work within the Home Office's <u>'Code of practice for sports'</u> governing bodies' and must comply with any immigration regulations, UK legislation and the principles of the points-based system as detailed on the <u>GOV.UK</u> website.

Length of endorsement

Governing body endorsements will be issued for a period appropriate to the period of approval for sponsorship, that is:

Type of application	Length of endorsement	
Sponsor	Endorsements for sponsors will not have an end date. They will be valid for as long as the sponsor continues to hold a valid sponsor licence.	
Migrant	<i>ligrant</i> For an initial maximum period of 3 years, with a further extension of a maximum period of 3 years. If the contract is	

for fewer than 3 years, it will be issued for the length of the
contract.

Change of employment

If a migrant is intending to change employer, their new employer must request a new governing body endorsement. The endorsement can be issued for the length of the contract or to the maximum period permitted within the route, whichever is the shorter. The new employer must assign a new certificate of sponsorship to the migrant to allow them to apply to the Home Office for new permission to stay. Permission to stay must be granted before the migrant can start work with the new employer.

Salary

The salary should be agreed as part of the contract between the migrant and the sponsor. This and the other conditions of employment should be at least equal to those normally given to a resident worker for the type of work undertaken.

Supplementary employment

International Sportsperson migrants are eligible to undertake supplementary employment under the Home Office supplementary employment regulations. The 'Supplementary employment' section <u>Workers and Temporary Workers: guidance for sponsors - Sponsor an</u> <u>International Sportsperson guidance</u> has more information on this.

Compliance with the Code of Practice for Sports Governing Bodies

In reviewing this criteria, England Hockey confirm we have reread the Code and agree to our roles and responsibilities as set out within. We confirm we have acted in full compliance with the principles of the Code during this annual review.

Section 2: Requirements

This page explains Field Hockey requirements under the International Sportsperson route. These requirements are effective from 1 July 2025.

Only the roles listed as part of this criteria are eligible for endorsement.

These requirements are applicable to England, Scotland, and Wales only.

Consultation

The following requirements have been agreed by the Home Office following consultation between the National Governing Bodies (NGBs) of England, Wales, Scotland for field hockey.

Prior to contacting the Home Office during the annual review of this criteria, England Hockey confirm that full consultation has been carried out, this includes any organisation that could be interpreted as an interested party, such as clubs, bodies, or player associations related to Field Hockey in the UK.

Review

The requirements will be reviewed annually. The next review will be in May 2026.

Length of season

The season for field hockey in general runs from 1 September – 30 April, although activity can take place outside of these times.

Requirements

The National Governing Bodies (NGB) for hockey have agreed that no endorsements will be issued to players or coaches for clubs. Please contact the relevant NGB below for more information regarding this decision. This decision will be reviewed annually in light of the structure of non-international hockey in each country at that time.

Category	Requirement	
Sponsor	Governing body endorsements will only be issued to National Governing Bodies wishing to appoint Performance Directors or coaches to work with their senior international team.	
Migrant	Performance Director / Coach	 Requests for endorsements will only be issued to Performance Directors or Coaches who meet all the following: have a minimum of 3 years international coaching experience at World Level (Hockey World Cup, Olympic or Commonwealth Games) and provide

evidence of delivering finalists at World Level (Senior)
 hold a GB Hockey Association Level 2 qualification or above or an equivalent qualification, which also includes awareness of Health and Safety and a First Aid qualification,
 have an awareness of child welfare issues and a relevant police check from their country of origin. Attendance at a Safeguarding and Protecting children course is required to practice once in the UK.
Have appropriate personal insurance.

Migrant endorsement eligibility where a sponsor no longer meets the requirements for endorsement

If a sponsor no longer meets the sponsor endorsement requirements set out in this document, they will be ineligible to receive migrant endorsements. Any existing migrant endorsements for the sponsor will remain valid for the duration of the endorsement.

Injuries, Absences and Suspensions

Consideration will be given to the following when applying the criteria: injury; a period of maternity or paternity leave; serious illness or any legitimate medical reasons; suspension; international duty; bereavement; or family crisis.

In order to obtain the governing body endorsement, the individual must not be subject to a provisional suspension or any unexpired period of ineligibility from playing and/ or coaching activities in any jurisdiction as a result of being charged with or found guilty of a corruption offence and/ or a doping offence and/ or another misconduct offence.

Dispute handling procedures

Any appeals against decisions by the groups will be referred to the Management Boards of the relevant NGB who each have an Appeal Panel to consider Appeals.

Where an application for a migrant covered by the requirements for a governing body endorsement as set out for International Sportsperson has been refused on the grounds that the migrant fails to meet the published requirements, the sponsor may seek a review of the application. The sponsor will have 28 days to request such a review. In these cases the NGB will refer the sponsor's evidence to an independent panel as set out below.

Where possible the sponsor's supporting evidence will be sent to the panel in advance for their consideration in order to allow an informed decision.

Sponsors should note that, in respect of any application, there will only be one panel available and the decision of the panel is final. Sponsors should therefore ensure that all evidence it wishes to present in support of its application is presented to the panel. If the sponsor has previously made an application that was unsuccessful at panel a further panel cannot be requested for the same player during the season unless his status changes and he meets the requirements whereby a new application can be submitted.

a. The Review

The request for a review may only be made by the sponsor for whom the governing body endorsement has been initially rejected by the NGB.

A review shall be commenced by the appellant lodging with the NGB and a notice of appeal within 28 days of the decision appealed against. The notice of appeal shall

- i. set out details of the decision appealed against and, if the whole of the decision is not appealed against, identify that part of it which is appealed against;
- ii. set out in full the grounds of appeal and an appellant shall not be entitled to rely in any ground of appeal not set out in the notice of appeal; and
- iii. be accompanied by a deposit of \pounds 150. The panel shall have discretion as to whether the deposit is returned.

The procedure for appeal will be in accordance with the NGB shall be comprised as detailed below.

b. The Panel

The panel will be appointed by the NGB. The appointed panel shall consist of the NGB's standard Appeal Panel personnel.

c. Power of the Panel

Field Hockey Governing Body Endorsement Requirements

An endorsement request may be refused if the migrant does not meet the relevant criteria set out in this document or fails to provide the mandatory documents. The NGB will notify a migrant in writing of any endorsement request which is refused setting out the reasons for refusal.

An individual shall have 28 days from the date of the written refusal to submit an appeal in writing to the NGB. An individual may only appeal on the basis that the NGB have not applied the endorsement criteria correctly.

The Panel shall consider the appeal and any evidence submitted in support and shall, as far as practicably possible, within 7 working days of the receipt of the appeal, notify the migrant of its decision.

d. The Decision

The panel will make a decision using the above criteria which shall be final and binding.

Section 3: Process for applying for a Governing Body Endorsement for International Sportsperson applications

National Governing Bodies (NGB's) need to apply to the relevant NGB (as set out above) for a sponsor endorsement in order to apply to UKVI for a sponsor licence.

To apply for a migrant endorsement from the relevant NGB, NGB's will need to complete and return an application provided by the NGB. They will either approve or not support the application for an endorsement. If an application is successful they will issue an endorsement containing a unique reference number to be used in respect of this.
